This agreement is entered into Between Buyer(s) and Seller for their mutual protection and especially for the protection and well-being of the Cat. It is mutually understood that failure to comply with any provision of this agreement may detrimentally affect the reputation of Indian River Ragdolls. For the sum of \$ \_\_\_\_\_, Seller does hereby transfer to Buyer, the Cat, subject to the following terms and conditions:

1. Buyer is purchasing the Cat as a pet only, and under no conditions may the Cat be used for breeding. This Cat is to be spayed or neutered, if not already altered prior to the date of purchase. However, if bought as a show-kitten, the Buyer may show the Cat in cat shows, if qualified pursuant to the rules of any particular cat show, as a kitten, alter, or household pet. Seller makes no representations nor guarantees whatsoever to the physical features, specifically including coat and eye color, as these may change as the cat ages, personality, temperament or the ability of the Cat to accumulate awards. All deposits are **non-refundable**,. Deposits are valid for up to 1 year from date of deposit.
2. If said Cat has not been spayed/neutered prior to the date of purchase, Buyer will spay or neuter said Cat prior to the Cat's attaining the age of six (6) months and furnish proof of such altering to Seller by having the veterinarian fax or mail a document stating that the cat has been spayed/neutered and enclosing a receipt for said procedure. The receipt needs to include the description of the cat, date of birth and breed/sex. In the event Seller does not receive such proof within thirty (30) days of said Cat attaining the age of six (6) months, it will be assumed that said Cat is being used for breeding, and an additional sum of \$\_\_\_\_\_ shall be due to Seller from Buyer. Upon receipt of spay or neuter documentation of said Cat, **TICA registration slip** will be forwarded to the Buyer.
3. Seller represents and warrants that the Cat is in good health and free of known ailments as attested in the health certificate provided by Seller. Indian River Ragdolls Cattery is FeLV/FIV/HCM free. The new owner has 3 working days to have the kitten checked by their vet. If the kitten is found unhealthy during that time, it can be returned for a full refund or replaced with another kitten of buyers choice.

4. Buyer will at no time allow the Cat out of doors unattended and without suitable control - that is, a secure, safe enclosure with protection from the elements, predators, and other hazards. Such enclosure is not to be used as primary housing for said Cat.
5. If for any reason Buyer becomes unwilling or unable to keep the Cat and provide the Cat with proper food, shelter, and medical attention, Seller agrees to take said Cat back from Buyer, with no reimbursement or refund to the Buyer. We will, at no charge to you, make every attempt to locate a suitable, loving family.
6. Buyer will at no time give, lease and/or sell the Cat to any pet shop, research laboratory, institution, animal shelter, cattery, or any other entity or similar facility.
7. Your kitten is to be given proper medical care including proper vaccinations on a schedule determined by a licensed veterinarian. Vaccines are current as of \_\_\_\_\_, another FVRCP shot is due 4 weeks from this date and then a 3rd one 4 weeks from that date. PLEASE adhere strictly with this vaccine regimen!! A Rabies vaccination should be given no earlier than 5 months of age. Distemper (FVRCP) and rabies vaccines should be given at least four (4) weeks apart to prevent any adverse reactions. Rabies at 5-6 months and then again 1 year later. In Florida, every 3 years after that.
8. The Cat is guaranteed against any genetic defects. If evidence of inherited or congenital disease develops within 1 year, proof from a licensed veterinarian is required in the form of a letter confirming the problem. In case of fatality, caused by inherited or congenital disease the kitten will then be replaced or refund made, whichever you prefer. The Seller must receive proof of the defect in the form of a complete necropsy report and a complete medical history provided by the attending veterinarian, performed at the Buyer's expense. No veterinarian expenses will be reimbursed.
9. Seller will not warranty the kitten against any adverse reactions to future vaccinations, or any future health problems.
